1 Introduction

- 1.1 This Modern Slavery and Human Trafficking Statement is a response to Section 54(1), Part 6 of the Modern Slavery Act 2015 and relates to actions and actions in the financial year 2024/25.
- 1.2 Metlab is committed to preventing slavery and human trafficking violations in its own operations, its supply chain and its products. We are strongly opposed to modern slavery and will work tirelessly with our customers and supply chain partners to tackle the insidious impact of modern slavery and human trafficking.

2 Organisational Structure

- 2.1 Metlab is a small independent family-owned business and has been operating successfully in the UK for almost 40 years. The Modern Slavery Act 2015 provides a legally binding framework which requires every organisation carrying out business in the UK, with a total annual turnover of £36m or more, to produce a **slavery and human trafficking statement** each financial year. Our turnover is less than this financial limit, but we believe it is important to produce a statement to demonstrate our commitment to working ethically and help to tackle modern slavery.
- 2.2 We operate a sourcing, warehousing and distribution business supplying chemical products and laboratory equipment to a diverse range of customers. We have an established supply chain network with major national and international manufacturers and importers of chemicals and equipment.
- 2.3 We employ around 27 people whose work involves customer service, finance, warehousing and customer delivery. We have completed an exercise to map our major supply chains to help us in our wider quest to reduce the risk of modern slavery in those supply chains.

3 Policies

- 3.1 We have developed a range of internal policies to support our approach to conducting business in an ethical and transparent business. These include the following:
 - 1. Anti-Slavery and Corruption Policy
 - 2. CSR Statement
 - 3. ESG Strategy
 - 4. Equality, Diversity and Inclusion Policy
 - 5. Tackling Modern Slavery Policy and Approach BS 25700
 - 6. Comprehensive HR Processes covering recruitment and selection, grievance policies, whistleblowing policies etc
 - 7. Baseline KPI's for assessing our performance

3.2 We endeavour to use our best efforts to work only with suppliers who share our values and commitment to tackling modern slavery and human trafficking in the UK and beyond.

4 Due Diligence

- 4.1 As part of efforts to monitor and reduce the risk of slavery and human trafficking occurring in supply chains, we have adopted the following due diligence procedures:
- 4.2 We consider the risks of modern slavery in staffing and recruitment and selection to to be low. We undertake appropriate pre-employment checks to ensure a right to work in the UK, with further identity checks as required. All contracts of employment and salaries are paid directly to our employees. We pay a minimum of the Real Living Wage. We no longer use recruitment agencies. We use our own processes for recruitment and selection as our staff turnover is relatively low. Many members of our team have worked with for 20 years or more.
- 4.3 We have an established and diverse supply chain and have worked with many of our major suppliers since the business was first formed in the early 1980's. Our ISO 9001 quality management system has a detailed and comprehensive process for supplier approval and we monitor product and service quality on a continuous basis using our QMS processes.
- 4.4 Our due diligence procedures aim to:
 - identify and mitigate potential risks in our business and supply chains;
 - monitor and respond to potential risks in our business and supply chains; and
 - reduce the risk of slavery and human trafficking occurring in our business and supply chains
- 4.5 Where possible we try to engage with local and national business forums created to share best practice and tackle modern slavery in a more coordinated manger and will be doing this throughout the 2025/26 financial year.

5 Risk and Compliance

- 5.1 Metlab has assessed ethical risks and has recently started to use BS25700 as a guide to our overall approach to tackling modern slavery and to better understands risks and their effective mitigation.
- 5.2 Our approach is formally monitored through a simple governance structure, and we use our existing quality management review processes for conducting a systematic and formal review of risk and compliance at least once a year.

5.3 In 2025/26, we propose to undertake more detailed and comprehensive mapping of our supply chains to have a clearer understanding of higher risk issues to develop plans and activities to mitigate those risks.

6 Effectiveness

- 6.1 Tackling Modern Slavery is a particular challenge for small businesses. In our case, we carefully select suppliers who operate at the international level. While our ability to influence the wider market is limited this does not stop us from trying. We make the best possible efforts to work with like-minded customers and suppliers to support the wider aim of individually and collectively tackling the exploitation of vulnerable people.
- 6.2 What we do is formalised within our existing management systems. This means we can be more effective in taking a practical and pragmatic approach to managing our own business well and working with partners and stakeholders so that the sum of our collective actions are greater than what we can do working on our own.

7 Our Priorities for 2025/26

- 7.1 We have much to do to build on the work we have already undertaken having produced our first modern slavery policy document in 2018, so we intend to focus on the following activities and actions over the next 12 months.
 - 1. Review and re-publish this statement and supporting documents on our newly designed website
 - 2. Continue to develop and improve our baseline KPI's to help us produce realistic and achievable improvement targets
 - 3. Continue our use if BS25700 to guide our progress in tackling modern slavery
 - 4. Invest in awareness raising through targeted training or our staff
 - 5. Complete the mapping of our main supply chains so that we become better informed about high-risk areas so that we are better able to mitigate identified risks
